### **Criminal Injuries Compensation**

Victims of family violence, and other crimes, who have suffered injury including bodily harm, mental and nervous shock or pregnancy as a result of the crime may be eligible to claim criminal injuries compensation.

There is a three-year limitation period from the date of the most recent incident to make a claim for criminal injuries compensation, however, it is possible to make a request for an extension of time.

The solicitors assist with applying for the necessary supporting documentation, and preparing and submitting claims to the Office of Criminal Injuries Compensation.

### **Wills and Deceased Estates (Limited Services).**

The solicitors can provide advice and assistance with:

- Simple Wills;
- Enduring Powers of Attorney and Enduring Powers of Guardianship; and
- The appropriate Supreme Court of WA application for deceased estates.

### **Family Violence Legal Service**

The solicitors advise, and provide limited representation in the Magistrates Court, for family violence, violence and misconduct restraining orders.

Prospective clients are encouraged to make contact with our services at an early stage. Solicitors may resolve these matters prior to them proceeding to trial.

The solicitors provide advice and limited representation in care and protection matters.
