Starting a Tenancy— Handy Tips

Tenant Responsibilities:

- Sign and return a copy of the written agreement to the lessor
- Pay the bond and two weeks rent in advance, and sign the bond lodgement form
- Complete and return the property condition report with photos attached within 7 days of receiving it
- Connect utilities gas, electricity, internet and phone
- If applicable, apply for any Centrelink rent assistance or Department of Housing Bond Assistance Loan
- Set up a tenancy file to keep all of your tenancy related documents

Handy tips!

 Get receipts or keep records of any money you pay to the lessor

- Keep copies of your agreement, property condition report, receipts and other tenancy documents in a safe place.
- If you have identified issues or problems, ask the lessor about them. If they agree to address these issues, get any agreement in writing

Hedland staff members Sabrina and Dollie were invited to attend the reopening of a refurbished and repurposed room within the South Hedland Police Complex.

Hedland police worked with artists Leah Brackin and her daughter Lilly, FMG, Dulux, Jupps, H & M Tracey and Ashburton Aboriginal Corporation to create the 'Manga Wakanha' Room, meaning Women's Path.

It is a respectful space, within the police station, for those wishing to speak with police or who are assisting in investigations of a sensitive nature such as family and domestic violence and sexual assault.

The feature mural is named "The Journey of Family"; The flower in the centre represents growth and the beauty of change. The flowing lines

represent how we navigate through life always changing, crossing paths, being challenged, strengthening and moving forward. The figures represent ourselves, our children, family, community, friends & all the people who walk beside us on our journey.



Karratha Emergency Services Event

PCLS domestic violence service was invited to attend the annual Emergency Services event with Karratha Police.

The event was at the Karratha Police Station. The street was closed down and the station opened up to the public. The police opened up the lock-up, had their cars, trucks and paddywagons out and about, the fire brigade put on a foam show and SES and St. Johns showed the community how they cut open a car and assist in major accidents.

The event focused on increasing positive engagement with police and other emergency services. The Domestic Violence Advocate and Victim

Support worker had the chance to engage with the public and talk about domestic abuse in our community and understand the community concerns.

Susanne, our financial counsellor, attended the event as well, handing out bags with information about PCLS services, and some tips and information sheets on increasing safety in the home, and how to assist a friend they are concerned about.

Indonesia Independence Day 2020

The Indonesia Independence Day is celebrated on August 17. This year marked its 75th anniversary.

It is the day when the proclaimers of Indonesian independence- Hatta and Soekarno proclaimed the independence of Indonesia

from the and Japanese authorities. People decorate their house and the streets with red and white ornaments which represent the colours of Indonesian flags. The Indonesian has various ways to celebrate it, both formally and informally.

This year in Hedland our PCLS Hedland migrant service worker Victoria, had the pleasure of joining the Hedland Indonesian community on the 23th of August for a wonderful day of



celebration, food and traditional games.

The Indonesian community is one of the most proactive groups in the town of Hedland. Victoria is always happy to assist the association in her role as a Community Migrant Support Worker.

The celebration at the Shay Gap Memorial Park in South Hedland included various party games, such as an egg and spoon race, kerupuk (chips) eating and getting a nail tied to string into a bottle.

In addition to being entertaining all the games also have a symbolic value and serves as reminder of the time before Indonesia had its independence. For example, eating kerupuk is a reminder of how people lived in poverty

during the colonisation.

With the gloom of travel restrictions keeping people from their families and home towns, this celebration was a great opportunity for the community to come together and find joy during the pandemic.
